Summary

- [Total number of permits](#) issued in June 2012 (561) are down from May 2012 (650). Total number of permits issued this month are up versus June 2011 (510).
- [Valuations](#) for June 2012 (\$18,248,079) are up from May 2012 (\$13,449,510).
- 2 [new single-family](#) permits were issued in June 2012.
- [Residential addition/remodel](#) permits issued in June 2012 (60) are down from permits issued in May 2012 (78).
- 0 [new commercial](#) projects were permitted in June 2012.
- [Plan review](#) activity for June 2012 (165) are down compared to May 2012 (186).
- [Rapid Review](#) permit and plan review activity for June 2012 (66) is down compared to May 2012 (83).
- [Total Contractor license](#) Issued in June 2012 (917) are up from May 2012 (100)

Fees/Revenues

- Building [Fees](#) for this month of \$361,567 are above the City's projected revenues of \$188,360.
- [Contractor license Fees](#) for this month of \$93,245 are above the City's projected revenues of \$19,167.
- Total Building Division fees retained by the City of Centennial as of the June billing total approximately \$280,466 which is above the projected revenue of \$224,370 (25% of total revenue).
- [Year-to-date](#), Building revenues of \$1,121,865 are above projected revenue of \$897,480.
- [Year-to-date, Contractor license](#) revenues of \$133,558 are above projected revenue of \$95,835.


