### **Boards and Commissions and Ad Hoc Appointment Committees**

The City Clerk staffed ad hoc appointment committees for Elections Commission during the month of June.

### **City Council Meetings**

### **Elections and Election Commission**

Three members of the Commission were appointed by City Council in June. Don Strickland was re-appointed to a three year term and Mary Ann Bledsoe was appointed to a three year term. Ms. Bledsoe was previously an alternate member of the Commission. Douglas Prechtel was appointed to a three year term as an alternate.

### **Liquor Licensing**

The Centennial Liquor Licensing Authority conducted a Public Hearing on June 3, 2010 concerning an application of a Hotel/Restaurant Liquor License for Rhythms Sports Bar & Grill LLC, dba Rhythms Sports Bar & Grill, 7101 S. Clinton Street, Centennial. This license was approved by the Authority.

The Authority also conducted two Public Hearings on June 17, 2010 concerning an application of a Retail Liquor Store License for Panj Aab, Inc. dba Willow Creek Wine & Spirits, 8200 S. Quebec Street #A2, Centennial, and a Change of Location of a Retail Liquor Store application for Jide R. Arije, dba Spirits of Piney Creek, 16748 E. Smoky Hill Road, Centennial. Each application was approved by the Authority.

Fifteen (15) renewal applications were processed by the Deputy City Clerk.

**Passports**

One-hundred and three (103) passport applications were accepted and sent to the U.S. Department of State in June. Fifty-one (51) photos were taken.

**Public Records Request**


The City Clerk’s office processed seven (7) public records requests in June. All requests were completed in a timely manner according to the Colorado Open Records Act.


