**USE RESTRICTIONS EXEMPTION FOR
ALCOHOL POSSESSION AND CONSUMPTION CENTENNIAL CENTER PARK**

Colorado law prohibits public consumption of malt liquor (beer other than 3.2%), vinous liquor (wine), and spirituous liquors in public, except in a business that has a liquor license or at a private event (by invitation only) or a permitted special event (generally allowed for non-profits only). The City of Centennial has prohibited the consumption of 3.2 % beer within Centennial Center Park.

The City of Centennial allows for the consumption of malt liquor (higher alcohol-content beer), vinous liquor (wine), spirituous liquors and 3.2 % beer within Centennial Center Park only for private, by invitation only, events. These private events must be held in areas designated by a City of Centennial rental agreement. It is recommended that applications for Use Restriction Exemption for Alcohol possession and consumption be filed with the City Clerk at least 30 days prior to the event, to ensure enough time for processing.

For all Permitted Areas:

Complete a City of Centennial Use Restrictions Exemption Permit for Alcohol Application (print or type), and return to the Centennial License & Records Clerk with the following documents and fees:

- a. Fee: \$25.00 (non-refundable)
- b. Copy of applicant's Driver's License, front and back

In addition - for Large Groups in the Amphitheater or areas other than the Coffee Shelter and Large Shelter:

- c. You must submit a diagram of the area to be licensed (not larger than 8 1/2" X 11") reflecting where alcohol will be served from (bars), storage of alcohol, walls, partitions, ingress, egress, security and dimensions
- d. Completed and Notarized: Use Restrictions Exemption for Alcohol possession and consumption questionnaire

NOTE: Colorado law prohibits the consumption or possession of alcohol by anyone under the age of 21.
