3. Site Plan showing location of proposed facilities and equipment to scale.
4. Building Facade Elevations showing location of proposed facilities and equipment to scale.
5. Notes on drawings indicating how specific requirements of Section 12-2-425 of the 2011 Land Development Code (attached) are being met.
6. To the extent not addressed in #5, a narrative that explains in plain and fact-specific terms why the applicant believes the application (1) qualifies as an eligible facilities request and (2) will not result in a substantial change. The narrative should state the applicable standards for each issue and discuss the facts that allow the City to find that the application qualifies for approval under Section 12-2-425.
